**7. Presentations on the proposed Highgate School Developments by Gail Waldman (Chair Highgate CAAC) and Nicky Gavron.**

Gail Waldman outlined the nine planning applications proposed by the School and showed their considerable extent with the aid of a slide presentation. She concluded that “the HCAAC considers all the applications cause harm to heritage assets”.

She was followed by Kate Machin-Miles reading Nicky Gavron’s presentation of the severe impact of the proposed developments on the hydrology and ecology of Tatum Field, the woodland area, Junior Field and wider area. The slides and both presentations are available on the HNF website *[link](#)*.

**8. Highgate’s Biodiversity Corridors and the HNF Citizen Science Project**

Maggy Meade-King outlined the importance of [wildlife corridors](#) linking Highgate’s large green spaces. The [Citizen Science project](#) aims to get everyone measuring the flora and fauna in their gardens and thinking of how they can improve biodiversity. This is particularly important at present so that local residents can provide evidence to support our opposition on ecological grounds to much of Highgate School’s development proposals.
